SGS conducted a Third Party verification of the JBS S/A **Sustainability Indicators**, provided by the CREDIT 360 System and based on the scope of verification and objectives and requirements agreed between SGS and JBS on 12-1, 4 June 202, 3 and using as verification criteria the requirements of the GRI *Standard* indicators or disclosures and ISO14064-3:2019; and Brazilian GHG Protocol Program.

The agreed level of trust is limited.

The materiality required for the verification was considered by SGS as 10%, according to the need of the intended user of the declaration of Indicators (GRI criteria).



- It has been prepared in accordance with ISO 14064-1:2018 and *GRI Standards disclosures*, cited above.


